Law no. 76/2015 – D.R. no. 145/2015, Series I of 2015-07-29
Ministries of Finance and of Solidarity, Employment and Social Security

First amendment to Decree-Law no. 172-A/2014, of 14 November and sixth amendment to the Statute of Private Social Welfare Institutions, by parliamentary assessment.

Ordinance no. 229/2015 – D.R. no. 149/2015, Series I of 2015-08-03
Ministry of Solidarity, Employment and Social Security

Creates the Cheque-Formação (Training Cheque) measure.

Ordinance no. 232/2015 – D.R. no. 152/2015, Series I of 2015-08-06
Ministry of Solidarity, Employment and Social Security

Defines the terms for engaging in the activity of childminder in the context of a host institution.

Law no. 84/2015 – D.R. no. 153/2015, Series I of 2015-08-07
Parliament

First amendment to the General Public Service Labour Law, approved as appendix to Law no. 35/2014, of 20 June, establishing half day as a new working hours arrangement.

Resolution of the Parliament no. 115/2015 – D.R. No. 154/2015, Series I of 2015-08-10
Parliament

Reinforces the resources of the Authority for Working Conditions and creates a National Plan to Fight Discrimination related to Maternity and Paternity.

Decree-Law no. 159/2015 – D.R. no. 154/2015, Series I of 2015-08-10
Ministry of Solidarity, Employment and Social Security

Creates the National Commission to Promote the Rights and Protection of Children and Young People.

Ordinance no. 237/2015 – D.R. no. 156/2015, Series I of 2015-08-12
Ministries of Finance, Environment, Territorial Planning, Energy and of Solidarity,
Employment and Social Security

First amendment to Ordinance no. 278-C/2014, of 29 December, which establishes the procedures and other conditions necessary for the granting, application and maintenance of the social fare established in Decree-Law no. 138-A/2010, of 28 December, as amended by Decree-Law no. 172/2014, of 14 November.
